The 59th AGM was held in Monks Eleigh village hall on Thursday 26th May 2022 at 7.30pm.

Apologies for Absence: Mr R Malster, Professor Revd Sir D MacCulloch, Dr N Karn and Dr K Briggs (Council) and 36 members of the Society.

The Acting Chairman, Dr Harvey Osborne welcomed everyone back to the Society's first face to face AGM since 2019. He wished to thank on behalf of the Society, the members of the Local History Group, Monks Eleigh Parish Council and the Trustees of Monks Eleigh Village Hall, in particular Mr David Mills, Ms Patti Derry and Mr Chris Eames. He also added for the benefit of the non-members present, what excellent value membership of the Society was, at just £15.

Since the last AGM the Society had lost two of its most stalwart and respected members: our President Dr David Dymond and our Chairman Mr Vic Gray. Fulsome tributes had been paid to both in various publications and online, since they had both earned huge respect for their academic careers and both had served with humility and modesty. Dr Heather Falvey had written the tribute to Dr Dymond in volume 64, and there had been others by Susan Dymond in the Guardian and Dr Mark Bailey on the SIAH website

Dr Osborne welcomed Professor Richard Smith and his wife Peggy. Professor Smith who has been invited by Council to become the Society's president, is Emeritus Professor of Historical Demography and Geography at Cambridge University, is a Fellow of Downing College and is on the Council of the Economic History Society.

1506 Minutes of the 58th Annual General Meeting (previously circulated)

The minutes of the 58th AGM held by Zoom in 2021 were signed by the Chairman. He also signed the minutes from the 57th AGM held in Melton in 2019. All in favour.

1507 Trustees' Annual Report for the year 2021-2022

The Annual report had been presented. All in favour.

1508 Financial Report

The Treasurer presented the annual accounts for the year 2021-2022. He was pleased with the return on the investments of 4%. Their level was set at medium risk. Through the good office of the Society's investment brokers, Charles Stanley, the value of the investments had increased by £5000. There was very little change to the Charters Series accounts since they had no investments. The adoption of the accounts was proposed by Peter Ledger and seconded by Mrs Christian. All in favour.

1509 Future volumes

Mr Sherlock paid tribute to Mrs Vivienne Aldous h for producing such a magnificient volume on the Manorial Records of Monks Eleigh. He also paid tribute to John Weller whose bequest had largely funded the project. Volume 66 would be the Manorial Records of Newmarket, jointly edited by Dr Joanne Sear from University of Cambridge and currently editor of the Journal of SIAH and Dr James Davis from Queens University, Belfast. Mr Sherlock was thanked by Dr Osborne for continuing to oversee the production of fine academic volumes for the Society.

1510 Charters Series

Dr Karn reported that Dr Vivien Brown has completed the text of her edition of the Bury St Edmunds Town Charters, and it is in the hands of the Charters Series editor. She is currently working on the Index. The Society intends to publish this large edition in two parts, and hopes that the first can be published at the end of 2022 or in early 2023.

1511 Election of Chairman

1517 Election of Independent Examiner

TRUSTEES' ANNUAL REPORT FOR THE YEAR 2022/23

- Trustees and Council members for the year were Dr Harvey Osborne (Chairman) Mrs Vivienne Aldous, Mrs Claire
 Barker, Dr Keith Briggs (SIAH representative), Ms Kate Chantry, Mrs Tanya Christian, Mr. Charles Farrow (NRS
 representative), Dr Jane Fiske, Dr Kate Jewell, Dr Nicholas Karn, Revd Professor Sir Diarmaid MacCulloch, Mr
 Clive Mees, Mr David Sherlock. Professor Richard Smith accepted Council's invitation to become President of the
 Society. Mr Clive Paine and Mr Robert Malster served as Vice-Presidents. Dr David Allen, Mrs Marion Allen and
 Mrs Vivien Brown also accepted invitations to be Vice-Presidents. Council consisted of six Honorary Officers and
 eight elected members.
- 2. The 2022 AGM was held at Monks Eleigh Village Hall where Volume 65 Monks Eleigh Manorial Records, 1210-1683.edited by Vivienne Aldous, was launched.
- 3. **MEMBERSHIP**: As of 1st January we had 305 members: 63 institutions and 242 individual members, including 4 Life Members. 2022 saw another drop in membership numbers but we are getting new ones joining via the website regularly, often from outside the county and from abroad.
- 4. **FINANCE:** It is pleasing to note a surplus for the year in our SRS finances. The reduction in subscription income has been offset by an increase in sales and royalties for the year. The Boydell and Brewer publisher cost of £5967 is for this year's publication of *Monks Eleigh Manorial Records*. Our postage costs are down for the year. Of concern is the reduction in the valuation of our investments. Down £7152 (-11.82%). Dividend return was 4%. Investment is pitched at medium risk for medium return. Investments are subject to market fluctuations. There is little to report in the Charters Series with a surplus for the year showing. Subscription income is down, however, royalty income has increased. There has been no significant expenditure.
- 5, **GENERAL SERIES**: The SRS will publish Volume 66 for 2023, *The Records of Medieval Newmarket* edited by James Davis and Joanne Sear. Future volumes will be *P.J.O. Trist's Diaries and maps concerning the 1953 East Coast Sea Floods edited by Denise Parkinson*, and *The First World War Diaries of George Punchard from Ipswich* edited by Paul Botwright.
- 6. **CHARTERS SERIES**: Dr Francis Young's volume on the Charters and Cartularies of the Franciscan Friars at Babwell will be published in 2023. Dr Vivien Brown is working on the Index to the Bury St Edmunds Town Charters, and the text is in the hands of the Charter Series editor. It will be published in two parts.
- 7. **WEBSITE:** The website is doing well and 104 books had been sold in 2022. The BBC Lucy Worsley programme on the Black Death meant copies were sold all over the world and it will now have to be digitised with about 7 other out of print volumes.
 - The first phase of the **Suffolk History Hub** is now live. It is hoped Phase Two adding digital material, will follow during 2023.
- 8. The Society will hope to meet at an AGM in Newmarket to launch volume 66, in May 2023.

INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF THE SUFFOLK RECORDS SOCIETY

I report on the Accounts of the Society for the year ended 30th September 2022

Respective Responsibilities of the Trustees and the Examiner.

The Charity's trustees are responsible for the preparation of the accounts. The trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed. It is my responsibility to:

- examine the accounts under section 145 of the Charities Act
- to follow the procedures laid down in the General Directions given by the Charity Commission (under section 145(5)(b) of the Charities Act), and
- to state whether particular matters have come to my attention.

Basis of the Independent Examiner's Statement

My examination was carried out in accordance with the General Directions given by the Charity Commissioners. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a 'true and fair' view and the report is limited to those matters set out in the statement below.

Independent examiner's statement
