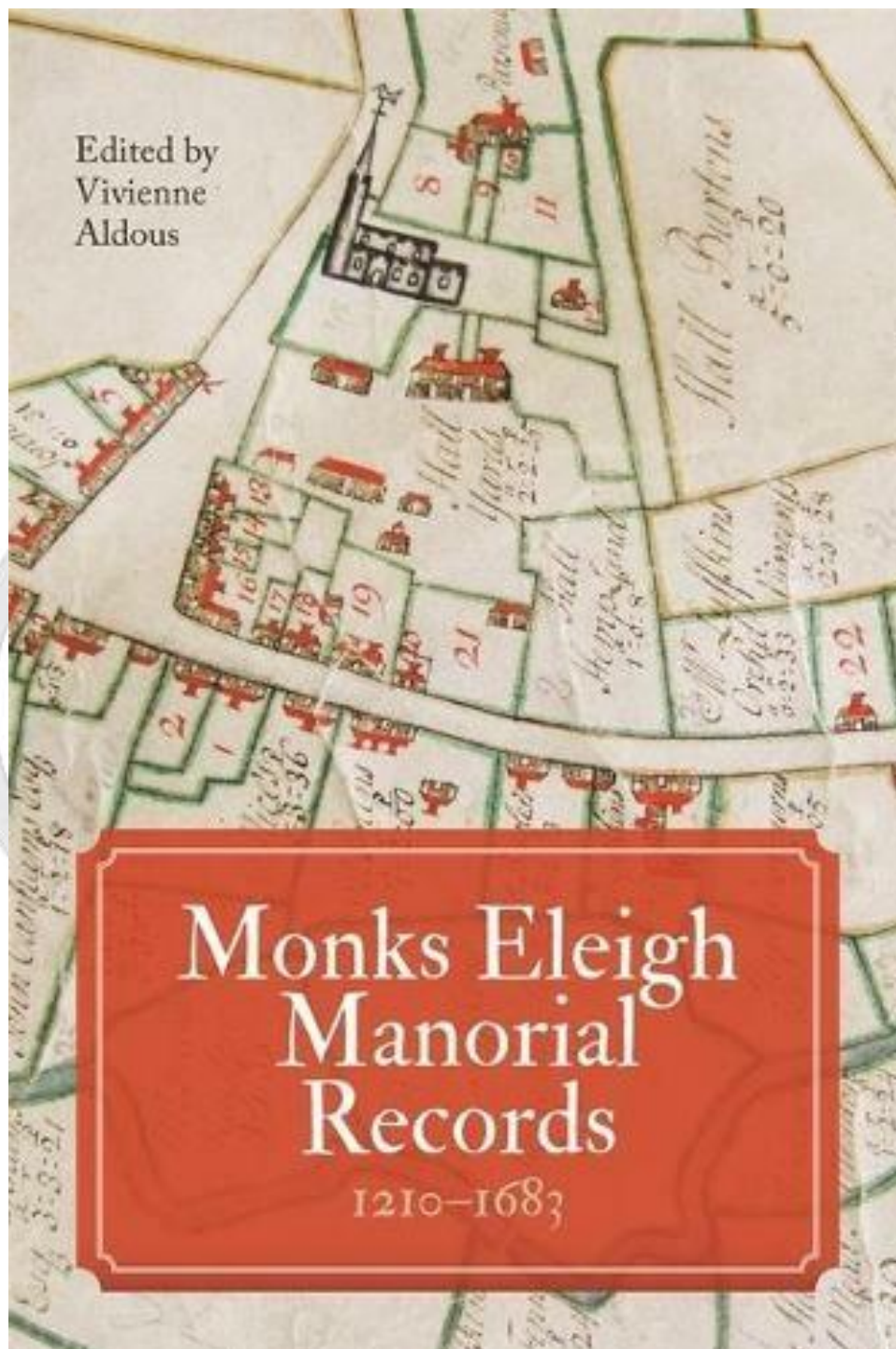

The list below comprises individual surviving manorial documents for the manor of Monks Eleigh, Suffolk, most of which are held at CCA. It was originally intended to include this list as an appendix to SRS 65, but it would have made a long book even longer and so is placed here on the SRS website as a supplement to the volume. More detailed catalogue entries are available via the online catalogues of CCA and TNA (the latter also includes the summary list of records brought together by the Historical Manuscripts Commission in the Manorial Documents Register), upon which the descriptions used in this list are based. Documents edited and published in SRS Vol. 65 are marked below with an asterisk (*) and some differ in date to the CCA and TNA catalogue entries owing to research and editorial decisions made in compiling SRS 65. For details of format and content of the different types of records, see the Introduction to SRS Vol. 65, pp. xxxiii – lii. This list is not comprehensive, mainly because many records are re-copied (some of them more than once) or exist in ‘buried’ form in registers and other series of compilations of records for multiple manors belonging to the priory of Christ Church, Canterbury at CCA.

Charters (in Original Document Reference Order)

The charters in the table below comprise items from both CCA and SA(I). CCA’s *Chartae Antiquae* series of original charters (CCA-DCc/ChAnt/...) has a complex provenance, but includes original charters relating to many manorial properties of the priory of Christ Church, Canterbury all over England, arranged in folders lettered alphabetically by placename. It also includes a number of items which are not charters, however, and the alphabetical association of folders and names is sometimes eccentric. For example, documents relating to Monks Eleigh in this series include documents in folder CCA-DCc-ChAnt/H because Monks Eleigh is called ‘Hellega’ in two charters in that folder. More logically, Monks Eleigh documents are in folder CCA-DCc-ChAnt/I/ because Monks Eleigh was usually called ‘Illeigh/Ylleigh’ in the medieval period, but there are also items relating to the manor in folder CCA-DCc-ChAnt/M/ (for Monks Eleigh) and in CCA-DCc-ChAnt/Z, a folder comprising an artificial collection of miscellaneous documents. The contents of each of these folders are summarily calendared, with a note of any enrolments, in CCA’s online catalogue¹.

Many (but not all) of the CCA *Chartae Antiquae* Monks Eleigh charters are also enrolled in priory cartularies or registers known as Register B (compiled 1250-1500) and Register E (compiled 1290-1300, updated to c.1500), with the following covering folio references:

- CCA-DCc/Register/B, fols 143r-146v (27 charters, with some contemporary marginal item numbers in Roman numerals);
- CCA-DCc/Register/E, fols 385r-387v (19 charters, with pencilled marginal item numbers 1908-1926).

All nineteen Monks Eleigh charters enrolled in Register E are comprised in the twenty-seven enrolled in Register B and they are enrolled in the same order (which is not date order) in both volumes. Some of the charters enrolled in these volumes have no corresponding original documents (see table below). In both volumes, the modern pencil foliation has been used for citations in SRS 65. Digital images of Registers B and E are freely available online on CCA's Image Database webpages.²

The table below lists the charters in original document reference number order, together with their corresponding enrolments and their numbered (date) order within SRS 65. Some of the items in these series which are not actually charters have been transcribed in other sections in SRS 65 and are listed in other sections below.³ A few others were omitted from SRS 65 on the grounds that they were not transcribed for J.B. Weller (for the editorial criteria for inclusion in the volume, see SRS 65, pp.xxxiii).

³ CCA-DCc-ChAnt/I/227B, (linked to MSSB/C/215-216) relates to a riotous event in Monks Eleigh in 1481 and is listed under *Petition and legal documents relating to a riot in 1481* below, whilst CCA-DCc-ChAnt/I/259 is a court roll (dated 1 August 1414) and is listed under *Court Rolls* below. In addition, a number of other documents with CCA 'charter' references, which are not charters, also exist relating to a dispute between the priory of Christ Church, Canterbury and Bury St Edmunds Abbey over their respective rights in the manors of Monks Eleigh and Hadleigh, both in Suffolk, [*late 14th / early 15th cents.*] for which no transcripts were made for J.B. Weller and which were not included in SRS 65: these are included below under *Miscellaneous Legal Disputes* and comprise:
