

You are warmly invited to the 56<sup>th</sup> Annual General Meeting of the Society on Thursday 17<sup>th</sup> May 2018 at 7.30pm in the Coach House Tea Rooms at Helmingham Hall.



Volume 61 in the General Series 'Household Inventories of Helmingham Hall, 1597-1741 will be introduced by the editor, Moira Coleman.

It is rare to find a sequence of household inventories surviving on the site they record; and rarer still when that house has been occupied continuously by generations of the family who built it circa 1510. The four inventories are dated 1597, 1626, 1708 and 1741 and during the span of these inventories, the Tollemaches rose from the status of gentry to earldom. Their household possessions reflect this transition vividly and an appendix traces the parallel development of Helmingham Hall. Removals from the Hall equipped the family's 17th-century home at Fakenham Magna in Suffolk and a further appendix is devoted to this property.

**MOIRA COLEMAN** is the author of *Fruitful Endeavours: the 16th-century household secrets of Catherine Tollemache at Helmingham Hall.* She is an Open University graduate, an independent scholar, now retired from a career in adult education.

Last year's change in distribution arrangements caught us all out and the results were less than satisfactory. I can only offer my sincere apologies to those members who were inconvenienced by the whole process. We have been assured that the teething problems have now been addressed but if there any further difficulties or your book has not arrived by the end of July please let me know.

## **INCREASE IN SUBSCRIPTIONS**

I am writing to inform you that after much deliberation Council has reluctantly decided to recommend to members at the forthcoming AGM that the cost of an individual subscription to the Society be increased to a minimum of £15. The current rate for individual members is £12.50 and has been the same since November 1997.

The Society's subscription income no longer covers the costs of the production of the annual volume and while we are all actively trying to encourage new members to join and our editors are tireless in their efforts to find different sources of funding and grants to assist with publication, the fact remains that the Society still has to subsidise each book. With several interesting volumes in the pipeline we have no wish or intention to reduce publication to one book every two years.

The costs of publishing the annual volume have risen substantially along with the related distribution charges. This year the production cost will be £6878 which makes each book £15.28 plus a further £4.70 for distribution to members. We no longer have the option of leaving copies at libraries and record offices for collection so apart from the few that are taken at the AGM and those that are hand-delivered, all the rest will be distributed by the courier service DPD.

The Council hopes that you will understand that this is an essential precaution to safeguard the future of the Society and that you will wish to continue to receive these beautiful and valuable volumes and so support our work in exploring and making available Suffolk's history.

# MINUTES OF THE 55<sup>th</sup> ANNUAL GENERAL MEETING OF THE SUFFOLK RECORDS SOCIETY AT HOLY TRINITY CHURCH, BLYTHBURGH ON THURSDAY 11<sup>TH</sup> MAY 2017 AT 7.30PM

The Chairman welcomed all members of the Society and its guests: Richard Halsey, Simon Loftus, Revd Canon Simon Pitcher, Revd Malcolm Doney and Mrs Meryl Doney, Mrs Jenny Allen, Dr Sue Powell. He also extended a warm welcome to the other visitors, promising that the AGM would be brief.

Apologies had been received from the Revd Professor Diarmaid MacCulloch, Dr Nicholas Karn, Dr Nicholas Amor, Mr Clive Paine, Mr and Mrs K K Gibson-Wynes, Ms Rebecca Abrahall, Mr and Mrs David Tytler and 80 members of the Society.

#### 1457 Minutes

The minutes of the 54<sup>th</sup> Annual General Meeting held on Thursday 12<sup>th</sup> May 2016 in the Crypt of St Edmund's Catholic Church, Bury St Edmunds had already been circulated and were approved and signed as a correct record by the Chairman. There were no matters arising.

## 1458 Trustees' Report for the year 2016-2017

The Chairman introduced the Report which had previously been circulated. Membership was falling very gradually and there was a continuing need to encourage new members but finances were very healthy and there was a strong list of excellent proposed volumes in the pipeline. There were no questions on the Report. The Report was proposed by Simon Loftus and seconded by Richard Smith and carried unanimously.

#### 1459 Financial Statement

The Treasurer introduced the Statement of Receipts and Payments for the year ended 30 September 2016. These had previously been circulated and had been examined by Mrs Rosemary Unthank. There was an excess of receipts over payments. Subscriptions just cover the cost of publishing the annual volume. Investment income was up slightly and the Society had now appointed brokers to manage the investments mostly due to the retirement of the Treasurer. There was a surplus for the year of £6336. The Medical Biographies project had been completed so the Society no longer held any funds. For the Charters Series, there had been no volume published, income was still accumulating. The Treasurer proposed the adoption of the accounts, seconded by Michael Boon and carried unanimously.

The Chairman thanked the Treasurer for his report. Mr Maule was now retiring after 17 years as Treasurer. In that time he had overseen sound investment and continued capital growth keeping the Society on a very sound financial footing and enabling it to pursue its stated ambitions of producing an excellent volume every year. He was a very public-spirited man who also had worked on behalf of Age UK, the Suffolk Wildlife Trust, and other charitable bodies. His accounts had always been clear and precise and he had invested wisely, enabling the Society to keep the annual subscription down to £12.50. Mr Maule was presented with a gift from the Society. He thanked members and said he felt sure he had left the Society and its financial well-being in a very safe pair of hands.

# 1460 Election of Chairman

The Chairman vacated the chair which was taken by the President, Dr David Dymond who proposed Mr Victor Gray. There were no other nominations. The proposal was seconded by Mr David Sherlock and carried unanimously.

### 1461 Election of Treasurer

Following his retirement, Mr Maule proposed Mr Clive Mees be elected Treasurer. This was seconded by Paul Simmons and carried unanimously.

## 1466 Report on volumes in progress

David Sherlock, the Co-ordinating Editor, announced that Volume 61 would be *Household Inventories of Helmingham Hall, 1597-1741* edited by Moira Coleman. The list of current projects that have been approved by Council for future publication is published at the back of volume 60.

Mr Sherlock was thanked by the Chairman for overseeing another excellent book for the Society and for continuing to supervise an impressive production line of proposed volumes.

# 1468 Volume 60 – The Restoration of Blythburgh Church 1881-1906

The Chairman introduced the editor, Alan Mackley who then gave a brief description of the twenty five year struggle between the patrons, residents and incumbents of Blythburgh and the Society for the Protection of Ancient Buildings to prevent the church from suffering the same fate as Covehithe and Walberswick or equally the dead hand of Victorianisation.

## TRUSTEES' REPORT FOR THE YEAR 2017/18

- 1. Trustees and Council members for the year were Mr Victor Gray (Chairman), Dr David Allen, Dr Nicholas Amor, Mrs Claire Barker, Ms Kate Chantry, Mrs Tanya Christian, Dr David Dymond, Dr Jane Fiske, Dr Nicholas Karn, Revd Professor Diarmaid MacCulloch, Mr Robert Malster, Mr Clive Mees, Dr Harvey Osborne, Mr Clive Paine, Mr David Sherlock, Professor Richard Wilson. Council consisted of six Honorary Officers and ten elected members.
- 2. At the 2017 AGM, held in at Holy Trinity Church, Blythburgh, Volume 60: *The Restoration of Blythburgh Church,* 1881-1906 edited by Alan Mackley was launched with an introductory talk by the editor. Later in the year a celebration to mark the 60<sup>th</sup> anniversary of the Society was held at the University of Suffolk with a lecture by Dr Harvey Osborne entitled *One Suffolk, Many Histories* together with various displays and a tea party which was much enjoyed by many distinguished guests including the High Sheriff of Suffolk, several mayors and other dignitaries, representatives of many other societies and groups as well as members of the Society.
- 3. MEMBERSHIP: As of 1 January 2018 there were 289 individual members (including 4 life members) and 73 institutional members. We have seen a very welcome rise in individual members, which can be attributed to extra marketing activities around the book launch and 60th Anniversary event. Suffolk County Council has further reduced the number of libraries stocking the Society's volumes to just one for the whole county. This has had a noticeable impact on the number of institutional members.
- 4. FINANCE: The deficit for the year was £3455. Our income from subscriptions is down this year and we have incurred increased printing costs of the annual volume. Other income has covered our overheads. We are fortunate to be still receiving a grant from Suffolk County Council and from the Gibson-Wynes Charitable Trust.

  The development of our website has increased our expenditure. Our investments have performed well. We have accessed £5000 of our investments to facilitate further website design and development. Our brokers have full discretion in managing the portfolio. We have donated £5000 to the Suffolk County Council Hold Project.

  No Charters Series volume has been published this year and the net income has been accumulated.

  Generally it has been a healthy year. However, in view of the rise in print and postage costs year on year, Council has felt it necessary to recommend a small increase in individual membership subscriptions in order to safeguard the position for the future.
- 5. GENERAL SERIES: While no new proposals for volumes were accepted during the year, the sequence of volumes for the next few years seems guaranteed. Forthcoming volumes are likely to include the Poor Law records of the Incorporated Hundreds of Loes and Wilford, 1765-1826, edited by Dr. John Shaw, and The Woodbridge Troop of the Suffolk Yeomanry edited by Dr Margaret Thomas
- 6. CHARTERS SERIES: The first of a two-volume edition of the charters of the Priory of St Peter and St Paul edited by Dr David Allen is likely to be published at the end of this year. Dr Vivien Brown's work on the Bury St Edmunds town charters continues.
- 7. 2018 will see the re-launch of the Society's website <a href="www.suffolkrecordssociety.com">www.suffolkrecordssociety.com</a> with the facility to purchase volumes and pay subscriptions online as well as offering the possibility of publishing digital documents
- 8. During the year Council noted with sadness the death of two former members, both historians of note, past editors and members of Council: Frank Grace and John Ridgard
- 9. The Society meets on Thursday 17<sup>th</sup> May 2018 at Helmingham Hall for the AGM at which we shall launch volume 61, *Household Inventories of Helmingham Hall, 1597-1741* edited by Moira Coleman.
